Manuscript page containing Juana Mariátegui's contract of sale of slaves in favour of Josefa Arias, dated 23 November 1833, before the scribe Gerónimo de Villafuerte, in Lima; followed by another contract by Lorenza Salazar in favour of José de la Puente, with the same date and date, before the same scribe. At the top of the first contract, it presents an incomplete fragment of the deed granted by Pedro Reyes, on 18 November 1833. In the lower part of the second contract, there is a small fragment of the deed of payment granted by Father Francisco Berdugo. The document has original foliation: "363", and in pencil: "365", with tear-off marks on the left edge. It comes from the Notarial Protocol N° 1023, from the notary Gerónimo de Villafuerte.

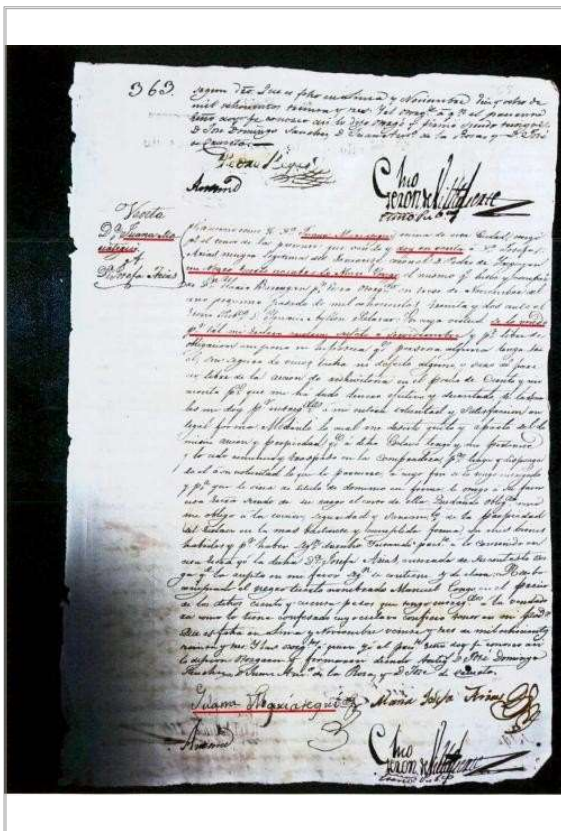


Image: Page 363 (365) straight

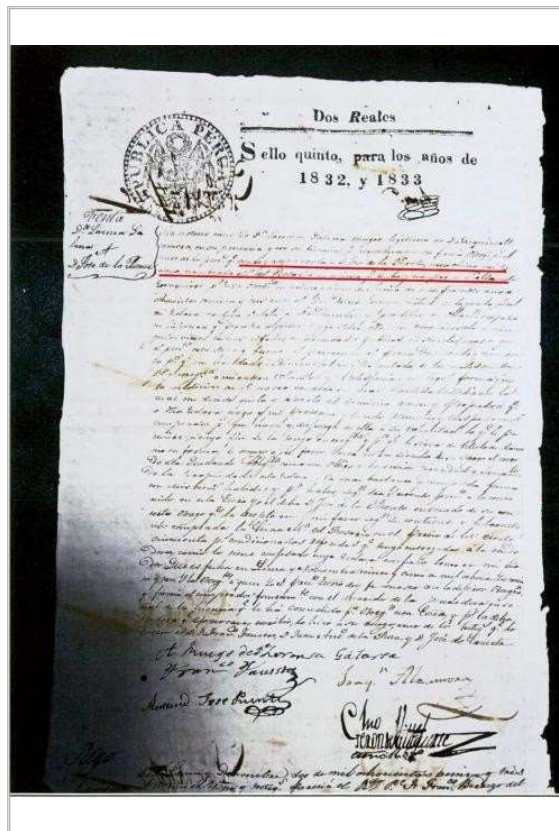


Image: Page 363 (365) back

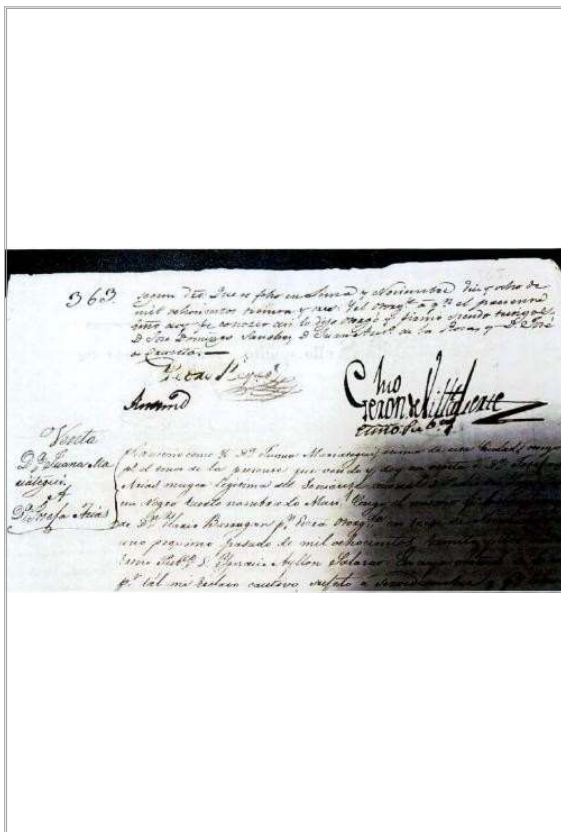


Image: Detail with foliation

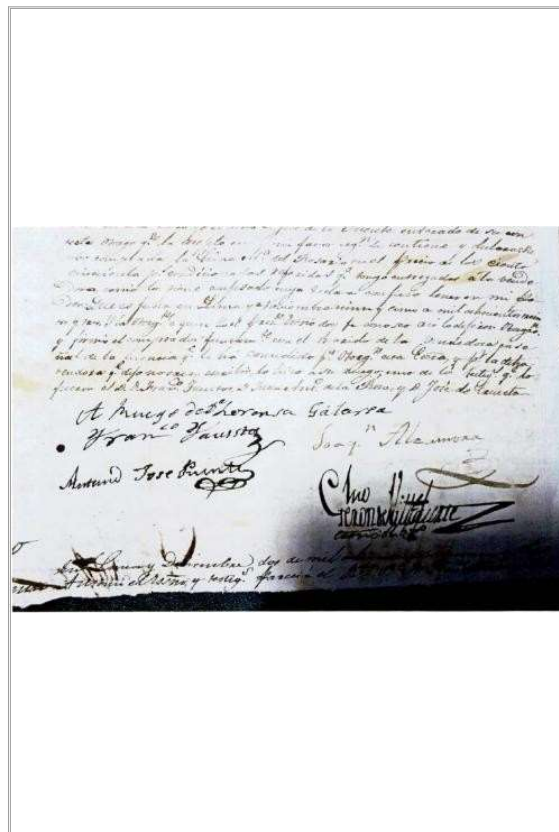


Image: Detail back

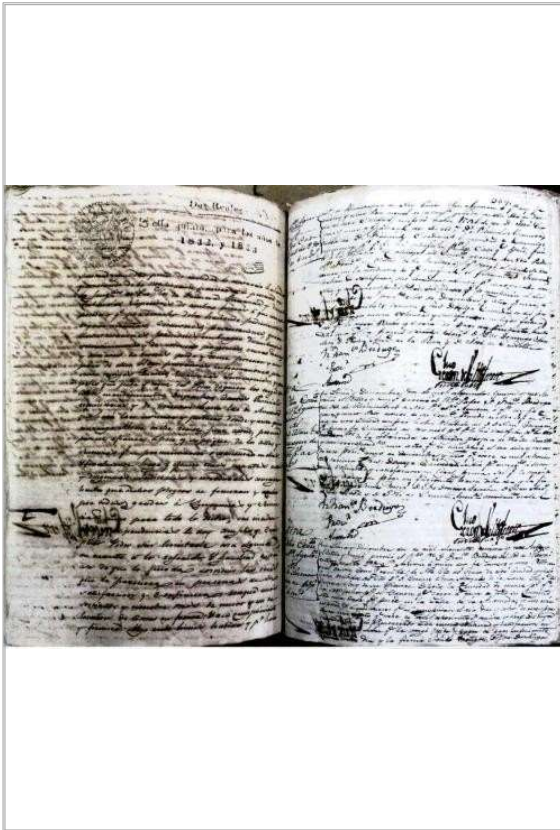


Image: Ref. Page 362v and 364r

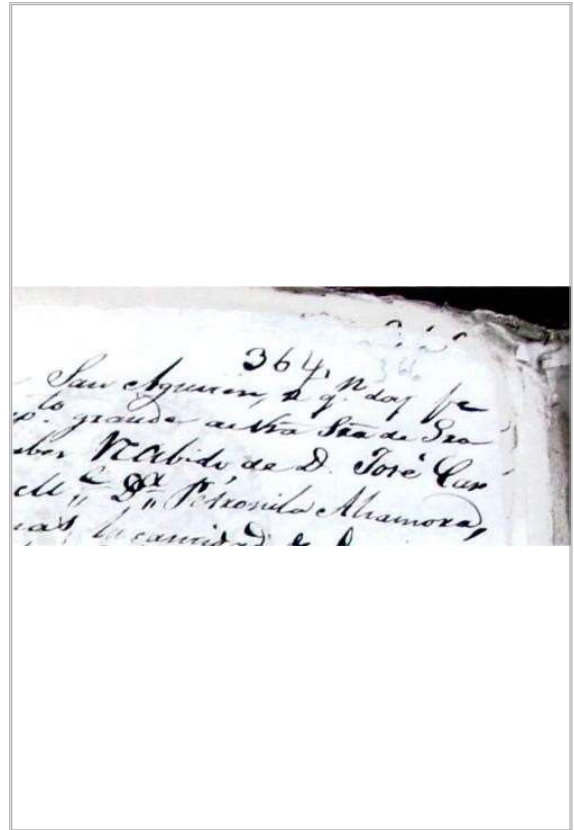


Image: Ref. Detail of page 364 (366)

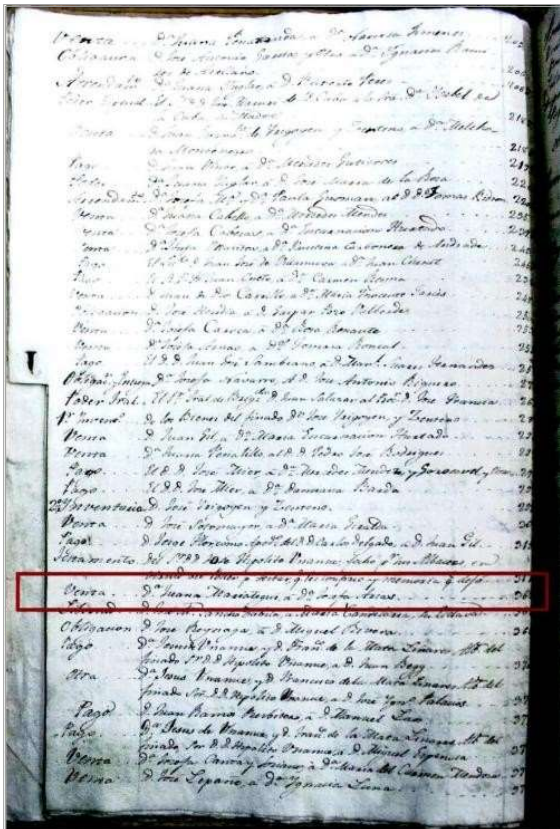


Image: Ref. P.N. 1023, Index J

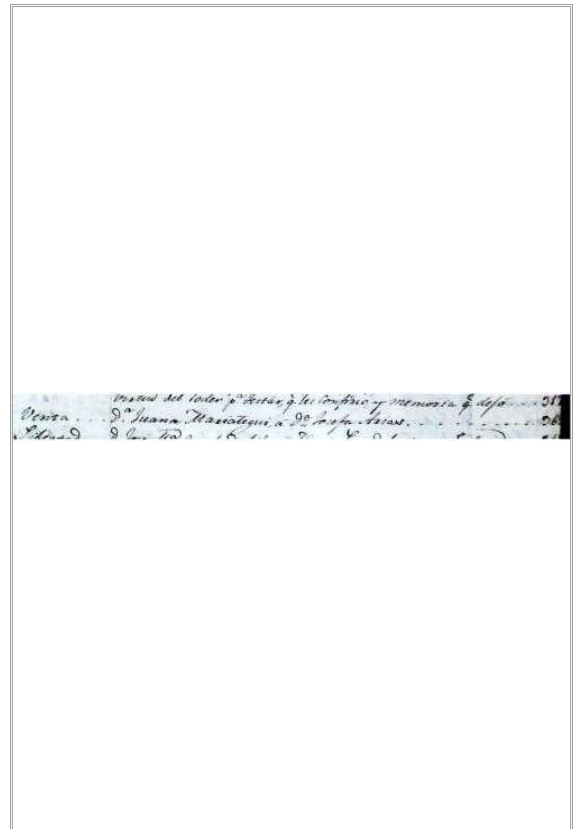


Image: Ref. Detail of writing mention
