Folio file fragment of document 152, file 6, from the background of the Notary Fund Aristónico Demetrio Ramírez Suzaníbar from Cajatambo, year 1867, with binding marks on the left edge, without foliation; it has two fiscal stamps on the upper right side that indicate "PORTE FRANCO" / "UN DINERO" / "CORREOS", with the heading written on top. It is a file "followed by Liberato Virhues on behalf of José Agapito Ríos, trustee of Cajacay, Carmen Bautista, trustee of Yamor, and the priest José de los Santos Morán, so that the power they gave him to represent them in the lawsuit against José Abelardo Padilla, for abuse of authority, is legalized (sic)". It is an original document (not a copy or testimony), with signatures of the applicant and authorities; the handwriting is italic

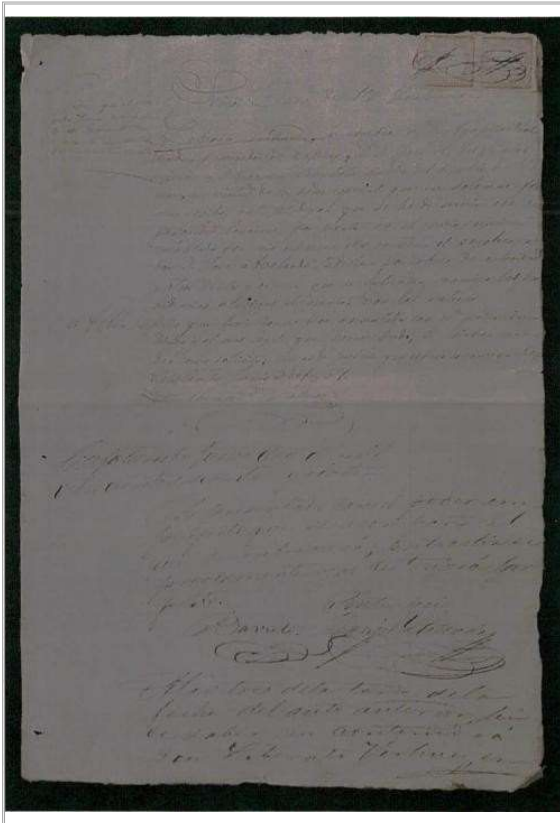


Image: Previous View

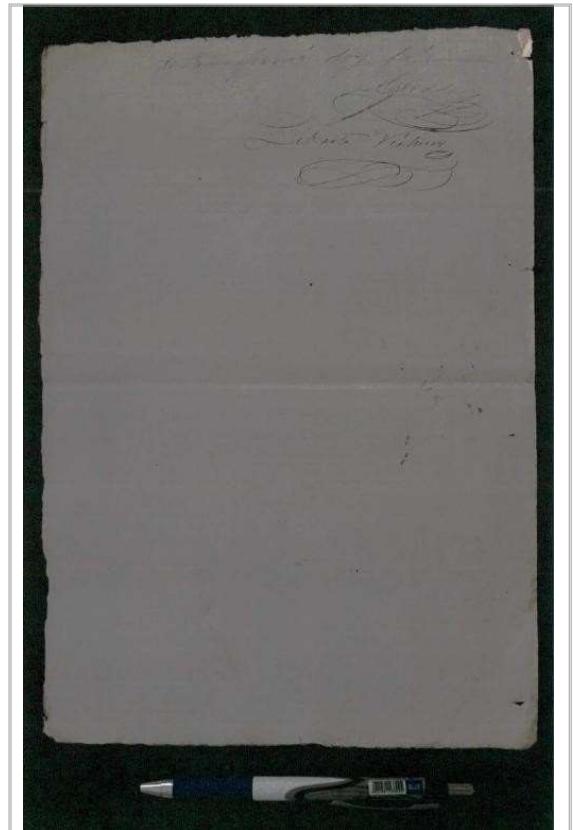


Image: Back View

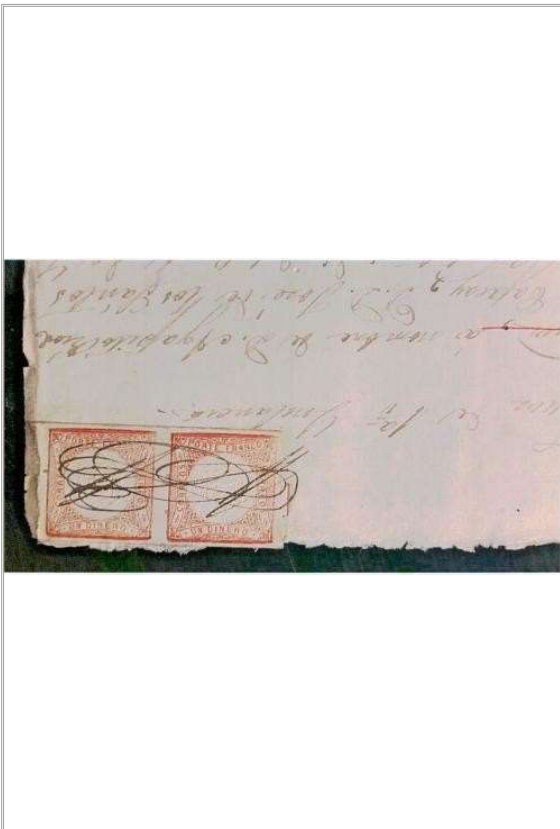


Image: Detail of tax stamps
