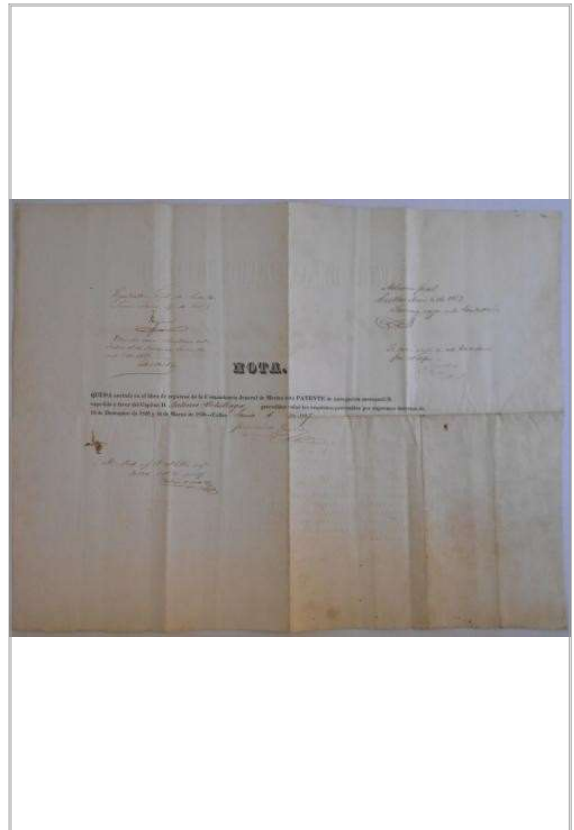


Image: Rear View

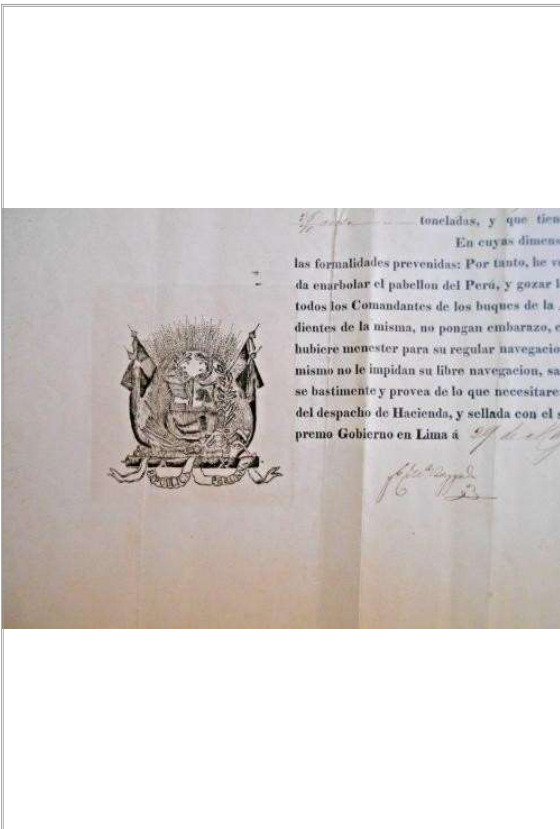


Image: Stamp and signature detail.

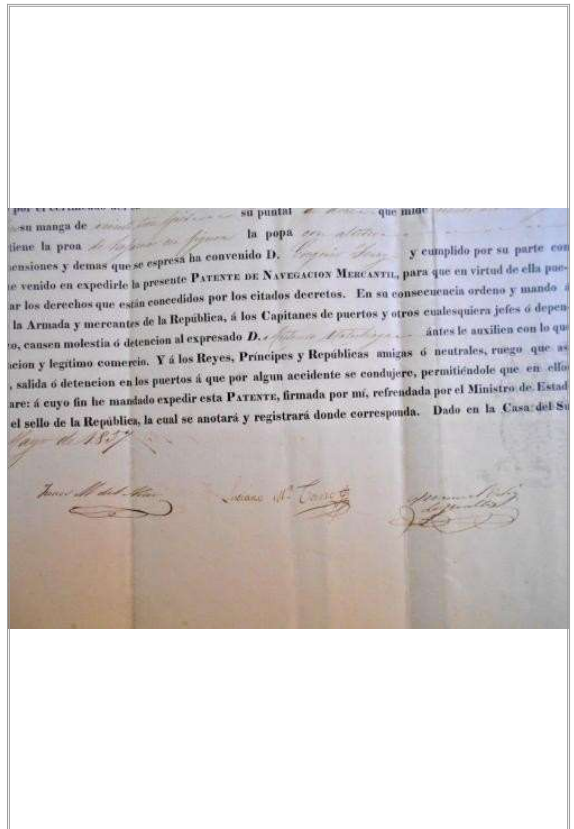
