It has a header with an oval stamp of the Ministry of Finance, the body with a predominant print and a text box to the right of the page. The document is a voucher from the Junta Directiva (Governing Board) in favor of Jorge Moreto, for 66 pesos with 5% monthly interest, for the reason of having granted a thousand pesos as part of a loan for "to provide public needs and give the army a boost capable [sic] to end the war"; issued in Lima on 25 January 1823 and signed by the members of the Junta Gubernativa (Governing Board); Felipe Antonio Alvarado and Manuel Salazar y Baquíjano; the signatures at the bottom of the body of the text refer to: "Inte Gonzalez", "La Mar", "Alvarado", "Salazar", "Francisco Valdiviezo"; also, in the back, signed, "Palacios Campos", "Bonet", "Sisilia", and with handwritten annotations: "Por recibido, hoy día de la fecha para la Tesorería para que verifique al pago como lo ordena el Supremo decreto, con intervención de la Contaduría. Lima, feb(o) 27 de 1823" ("As received, today of the date for the Treasury to verify the payment as ordered by the Supreme Decree, with the intervention of the Accounting Office. Lima, 27 Feb(o) 1823.") Its state of conservation is regular, with slight deformation of the support by humidity and oxidation by effects of the ferro-galic ink, irregular edges and tears; document shows on the upper left oxidation and burns caused by two metal staples; it also has numbering on the upper right: "35" and "10".




Image: Front View




Image: Detail of signatures




Image: Rear View
