In the left margin we can see a cancellation on 31 March 1571, signed by Diego de Aramburu, in which we can see the signature of a notary, possibly Diego Gutiérrez. The document is in fair state of preservation, with the edges scratched and damaged; it also has moisture. Blurred foliation completed in 865 can be seen.
