The Directorate of Recoveries of the General Directorate of the Defense of Cultural Heritage of the Ministry of Culture of Peru announces the theft of two (02) documentary assets: an exploration report issued by two Jesuits to the Central Lima Government, year 1745, and a handwritten file on Captain Geronimo de Aliaga, first half of the XVII century, both related to the documentary collections of the National Archives of Peru, <i>Correos</i> headquarters, located in the district, province and department of Lima. The documents were identified in Argentina and the case was reported to Peru on 20 November 2020.

Description:

Six-page (06) document consisting of a "report made by Jesuits priests Fathers Miguel de Eysaguirre y Carlos de Pastoriza of the Society of Jesus of all that happened in the expedition that they have made to the jungle by order and instruction of the Most Excellent Joseph Manso de Velasco, Lieutenant General of the armies of (...)", dated 13 October 1745, in Lima. The document consists of a report to the Central Lima Government by the two Jesuit priests, who were sent to the jungle in 1745 to interview the rebel Juan Santos Atahualpa. It exhibits regular state of conservation, with the presence of humidity.



Description:

Three hundred and twelve-page (312) document, in a hardcover volume, containing a handwritten file. It is about the *"Probanzas de los servicios quel Capitán Girónimo de Aliaga. Peru, c.1533-1647"* ("Proofs of Capitán Girónimo Aliaga Services. Peru, c.1533-1647). On one of the pages, we can see the number 475, where there is a request by Álvaro de los Ríos y Berris, husband of Juana de Villafuerte, in the lawsuit against Luis de Agüero, on the *repartimiento* (land division) of Lunahuaná, before the Royal Court at Lima; the request is addressed to the M.P.S. ("Very Mighty Lord", which is the institutional address form to the Royal Court at Lima). From the handwritting, it corresponds to the first half of the XVII century. The binding shows signs of being later than the document, as it is hardback and not leather.
