Document with loose bifolios, in vertical format, manufacturing support of the eighteenth century, with humanistic ink writing running to the right. It consists of a request by Pablo de Belasco to the authorities of Pucará, to provide witness information on will of Jacinto de Basconcelos. Then the authority summons this information from witnesses that are presented. The process begins on 28 August 1758. It has a regular state of conservation; possibly decontextualized from a larger documentary unit (file or bundle). It has oxidation of support and ink, by the coloration and scattered brown halos, which are also shown on opposite side of the support; deteriorated edges with presence of moisture and oxidation of support.






Image: General View 1






Image: General View 4






